## Discover Schechter Credit: Application and Instructions

The **Discover Schechter Program** provides a reduction in tuition of \$2,000 per child per year for three consecutive years. The credit is available to all new families, and is based on the family's 2011 Adjusted Gross Income as reported on IRS Form 1040, 1040A or 1040EZ. This application is due February 10, 2012. Please note that late applications will not be accepted.

### Eligibility Requirements:

- 2011 Adjusted Gross Income must be below \$400,000
- Family's assets (excluding equity on primary residence and retirement accounts) must be less than \$350,000
- To maintain the grant, families must submit a new application and continue to meet eligibility requirements each year
- Families may receive a grant or credit from only one of the following programs: Traditional Financial Aid, iCap credit or Discover Schechter credit
- This credit may be revoked if a 2011 tax return is not provided on or before May 1, or if the 2011 tax return shows that the family does not meet eligibility criteria
